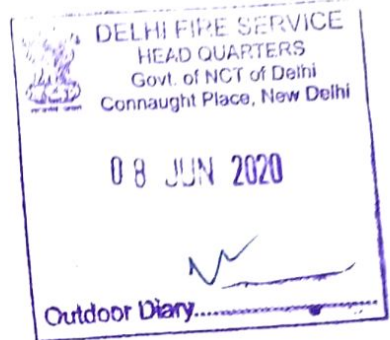

Delhi-86 comprised of basement, Ground and 01 upper floors owned/occupied by M. D. Indraprastha Sr. Sec. Public School was issued Fire Safety Certificated vide this office letter no. F-6/DFS/MS/School/2014/484 dated 16.04.2014. The premise was re-inspected by the officer concerned of this department and observed that all the fire safety arrangements as provided in the premise found in good working condition and have therefore deemed complied with the fire prevention and fire safety requirements in accordance with Circular No. F-16/Estate/CC/Fire Safety/2011/3298-3398 dated 01/03/2011 issued by Director of Education and verified by the officer concerned of fire service on 29.04.2017 in the presence of Smt. Seema, Principal and the building/premises is fit for occupancy Group B Educational for ground and first floor only with effect from *...17/5/17...* for a period of three years, subject to compliance of the conditions mentioned below:

Conditions for the validity of Fire Safety Certificate:

1. All the fire safety arrangement provided there-in shall be maintained in good working conditions at all times.
2. Loss of life or property due to non functional fire safety measure shall be at the responsibility of the management.
3. The trained fire fighting staff should be available round the clock.
4. Any deviation with regard to the construction etc shall be verified by the concerned building sanctioning agency.
5. This certificate cannot be treated in any case for regularizations of unauthorized construction.
6. The owner/occupier shall apply for renewal of this Fire Safety Certificate to the Director of Form 'J' [sub rule (1) of rule 37] along with a copy of this Certificate, six months prior to its expiry".
7. The owner / occupier shall submit a declaration every year in form "K" provided in the first schedule of Delhi Fire Service Rules 2010. The form is available on WWW.dfs.Delhigovt.nic.in
