


Sir,

4. That the school shall comply with the provisions of Section 10 (1) read with rule 125 of DSEAR 1973.
5. That the school shall submit comply with the clause 14 of order No.F.DE/15(56)/ACT/2009778 dated 11.02.2009 in r/o maintenance of DRF. School also ensure to follow FN-21 'Accounting by schools' as issued by the Institute of Chartered Accountants of India (ICAI) for proper accounting treatment.
6. That the school shall make payment of salary and other admissible allowances to its teaching /non-teaching staff as per on going CPC through Bank/RTGS.
7. That the school shall take the approval of the DoE for running Pre-School and Pre-Primary Classes within 02 months of issuance of this letter.


